We're suggesting a byo BBQ as this saves us the issue of catering, rsvp, etc.

Those of you that have a portable BBQ, and who would like to bring it along, will ensure that we don't overload the ACTMCC one.

During the BBQ we'll go through the annual TCC Presentation of awards.

See the list of trophy recipients elsewhere in this Newsletter, but also be aware that there will be awards made acknowledging our wonderful Observers and Officials.

We also have the Tim Seary Trophy, and the Presidents Trophy, annually awarded to highly valued members of TCC.

PLEASE NOTE:

Although TCC has invested hundreds of hours of members time, along with ACT Government Grants, in getting the Trials Park infrastructure in place, we are yet to sign up as tenants of Fairbairn Park.

It is important that you all understand that all fees collected will be passed on to ACTMCC.

You also need to understand that we could not provide this ride day, as the TCC, without a serious increase in the fees we are charging.

We elected to use this format, after discussions with other Clubs, a number of years ago. We were trying to overcome the same few riders getting the trophies at each Club Trial. 2014 Calendar

We do need a Calendar for our next season, however we all need to consider all of the issues prior to making hasty statements or decisions.

Most importantly we need **you** to say, "I will organise a Club Trial at....."

or, "I will run a practice day on.....", or "I'll co-ordinate the W

omens Cup......"

Please don't tell us "We need to run this", or "We must do that".

Remember these items.

Riders are always the ones who want "us" to run Two day events. Experienced Organisers are much happier co-ordinating One day events. Three quick reasons......Observers....Caterers....First Aid.....

Please think of how many Trials **you** plan to travel away to in 2014 before you expect "everyone else" to travel to our events. There is a very limited number of potential competitors out there.

Don't clash with other 'big" events.

Have an incentive to attract riders to our event.

Consider the following.....Rounds 1 and 2 of the 2014 World Trials Championships are being held at Mt Tarrengower in Victoria on April 12th and 13th.

The Glenmaggie Easter Two Day Trial is on the following weekend of April 19th and 20th.

These two events will attract many of Australia's travelling Trials riders, so it's probably not the best time to be running an Open Trial in Canberra.

The Aussie Titles will be held in Tasmania on October 4th and 5th and there should be a few TCC members attending.

The NSW Trials Titles should be a Two Day event at Pacific Park in August.

The NSW Classic and Post Classic Titles should be held near Denman in July.

The June long weekend has the Argyle Trial in Victoria, and the Queensland Titles as well.

If TCC chose to run one Open Trial in 2014, and combined the Womens Cup with the Howard Wallace Masters Shield, we would have the incentive of two different groups of enthusiasts. Perhaps in September in the hope of catching the travelling Trials riders on their way to Tasmania. Think about it......

NSW must liaise with the other States before setting their (our) Open Trial calendar.

What is critical for our Club, is to get set up at Fairbairn Park in such a way that our members have the benefit of being able to use the Trials area on a regular basis.

Remember that "we" are all going to have to pay to ride there, but we need to minimise that cost.

You don't have to be on the Committee to be an organiser, but you do have to put your hand up to help.


