7 CLASSES OF COMPETITION:

Open Solo, B Grade, C Grade, Women's, Clubperson, Twinshock, Classic, Sidecar, Veterans 40-49, Veterans 50-59, Veterans 60+, Open Junior, Junior Women's, Introductory, Introductory Junior, Mini Bike; Air Cooled Monoshock.

8 AWARDS AND PRIZEMONEY:

Trophies will be awarded to 1st, 2nd and 3rd place in all grades with the exception of Veterans. In the event of only three entries in a class trophies will be presented to 1st place. Veterans will awarded 1st place trophies in each class only.

9 ENTRIES TO CONSTITUTE A CLASS:

- 10.1. To constitute a Class, the number of contestants entered and competing in each Class shall be 3.
- 10.2. Should there be insufficient entries in any Class of Competition, the decision to run or cancel the Class, or to combine events and re-distribute any awards and / or prizemoney, will be at the discretion of the Promoter subject to Motorcycling Queensland approval.

11 RACE FORMAT:

This event is to be run under the FIM no-stop rules as per the MA rulebook. Number of sections and laps will be advised at riders briefing. Riders will be released from the scrutineering area at 2 minute intervals (in groups of 3-4) to begin the course. The starting order will be announced at riders briefing. A peer- scoring system will be used whereby the groups of 3-4 riders stay together for the duration of the event and share the scoring responsibilities as a group. All riders will have 5 x hours to complete their specified laps. The competition secretary will be responsible for the start order.

12 MACHINES AND RIDERS:

- 12.1 All machines entered must comply with the current GCR's for Moto Trials Competition.
- 12.2 Multiple entry of the one Machine in the same Class of Competition is not permitted.
- 12.3 Competitors including Minders are to present themselves dressed for competition including; helmet which is to be in good condition and complies with 23.1 or 30 of the GCR's, together with bike, competition licence to Scrutineering at the time listed below.
- 12.4 Motorcyle tyres are to be a Trials Universal Pattern.
- 12.5 Helmets are mandatory. All persons including officials using any bike, trike or quad at an event must be wearing a properly secured helmet.

13 NAME PLATES:

13.1 Identification plates must be fitted to all machines as per GCR's 23.2.3

14 RIDERS BRIEFING:

A Riders Briefing will be held prior to the commencement of racing and ALL Competitors MUST attend the Riders Briefing. Details will be included in Final Instructions. RIDERS BRIEFING IS A NON SMOKING AREA.

15 DRUG AND OR ALCOHOL TESTING:

- 15.1 All competitors and officials are advised that as part of the MA drug education program, drug testing may take place at any competition in accordance with Australian Sports Commission policy as implemented by the Australian Sports Drug Agency.
- 15.2 If any doubts exist over banned substances it is recommended competitors telephone the Drugs in Sport Hotline 1800 020506. When drug testing takes place, the payment of prizemoney may be delayed at the Motorcycling Queensland discretion until the results of the tests are known.

17 CODE OF CONDUCT:

All Competitors, Officials and Parents are reminded of the Motorcycling Australia By-Law - CODE OF CONDUCT (as stipulated in the GCR's) which is a guide to appropriate behaviour at all Motorcycle Race Meetings. This CODE OF CONDUCT applies to this Meeting and will be enforced.

For the purposes of drug & alcohol testing, the commencement of the meeting will be deemed to be 8am with the completion of the meeting for the participant being when the participant has vacated the venue.

19 PENALTIES – PLEASE NOTE Competitors will incur a one (1) point per minute late for machinery examination and exclusion after sixty minutes late. Competitors handing in a scorecard within 15 minutes after sections have closed will not incur a penalty. Competitors handing in a scorecard later than 15 minutes after sections have closed will be given a one (1) point per minute up to 30 minutes late. Competitors handing in scorecard more than 30 minutes after sections have closed will be excluded from the results (DNF).

20 NOTES AND WARNINGS:

- 20.1. No Dogs. (Guide dogs excepted)
- 20.2. Reminder to juniors to bring Log Books.
- 20.2.1. A junior rider's age on January 1 will determine his/her age for competition in that year. However, a rider may move to the next higher class when eligible to do so at any time in the year, but once a rider moves to the higher age class in any competition they may not move back to the lower class. Point earned in a lower class will not transfer to the higher class. This rule will apply to all riders up to and including 16 year olds.

CONTRACT TO PARTICIPATE IN THE "THUNDERBIRD PARK TRIALS CLASSIC EVENT" WARNING! THIS IS AN IMPORTANT DOCUMENT WHICH AFFECTS YOUR LEGAL RIGHTS AND OBLIGATIONS. PLEASE READ IT CAREFULLY AND DO NOT SIGN IT UNLESS YOU ARE SATISFIED YOU UNDERSTAND IT.

HEREBY AGREE with Motorcycling Australia Limited ("MA") that I am by this agreement entitled to participate in the motorcycle activity/meeting listed in Schedule 2 (hereinafter called "the Meeting" or the "Event") at the venue listed at Schedule 3 (hereinafter called "the Venue") on the terms and conditions set out in this document.

2. DEFINITIONS In this declaration:

- "Claim" means and includes any action, suit, proceeding, claim, a) demand, damage, cost or expense however arising including but not limited to negligence but does not include a claim against a Motorcycling Organisation under any right expressly conferred by its constitution or regulation;
- b) "Indemnitees" means and includes the persons, organisations and bodies corporate whose names appear in Schedule 1.
- "MA" means Motorcycling Australia Limited; "State Controlling Body" (SCB) means a state or territory d) motorcycling association affiliated as a member of MA;
- "Motorcycling Activities" means performing or participating in any e) capacity in any authorised or recognised Motorcycling Organisation event, meeting or activity;
- "Motorcycling Organisation" means and includes MA, and the MA f) members (including the SCBs and affiliated clubs) and where the context so permits, their respective directors, officers, members, servants or agents.

3. ACKNOWLEDGMENT OF RISKS, DANGERS & OBLIGATIONS

I ACKNOWLEDGE that:

- motorcycle sport is dangerous and that by engaging in the sport a) (whether as a competitor, recreational rider, coach, official or media) at the Meeting I take and am exposed to certain risks and dangers and am under certain obligations as follows:
- that I may be injured, physically or mentally, and may be killed; that my machinery or equipment may be damaged, lost or destroyed; ii)
- that competitors may ride dangerously or with a lack of skill; iii)
- that track or event conditions may be hazardous and may vary iv) without warning or predictability;
- v) that organisers, officials, landowners/track operators and any agents or representatives of those in charge of meetings are frequently obliged to make decisions under pressure of time/or events;
- that any policy of insurance of or in respect of my life or physical or
- mental health may be voided; that there may be no or inadequate facilities for treatment or vii) transport of me if I am injured;
- vii) that I have an obligation to myself and to others to act safely and within the rules and regulations of MA;
- the Indemnitees do not make any warranty that the services at the b) Meeting will be provided with due care and skill or that any materials provided in connection with the services will be fit for the purpose for which they are supplied;
- c) to the extent that any warranty is implied it is excluded to the full extent permitted by law;
- have voluntarily read and understood this warning and accept and d) assume the inherent risks in participating in the Event.

4. WARNING UNDER THE FAIR TRADING ACT 1999 (VIC)

- Under the provisions of the Fair Trading Act 1999 (Vic) several conditions are implied into contracts for the supply of certain goods and services. These conditions mean that the supplier named on this form is required to ensure that the recreational services it supplies to you are: - rendered with due care and skill;
- as fit for the purpose for which they are commonly bought as it is reasonable to expect in the circumstances; and
- reasonably fit for any particular purpose or might reasonably be expected to achieve any result you have made known to the supplier.

Under section 32N of the Fair Trading Act 1999, the supplier is entitled to ask you to agree that these conditions do not apply to you. If you sign this form, you will be agreeing that your rights to sue the supplier under the Fair Trading Act 1999 if you are killed or injured because the services were not rendered with due care and skill or they were not reasonably fit for their purpose, are excluded, restricted or modified in the way set out in this form. I understand and accept the Indemnitees will continue to rely upon this declaration as evidence of my fitness and ability to participate.

I acknowledge and agree that if required, the Indemnitees (or any of them) may arrange medical or hospital treatment (including ambulance transportation) for me. I authorise such actions being taken by the Indemnitees and agree to meet all costs associated with such action. I understand it is compulsory for me to have ambulance insurance in some form and I accept responsibility for the cost of ambulance transportation, ambulance cover and further agree to maintain ambulance cover during the term of my license / membership.

7. PRIVACY
