#### 1 ANNOUNCEMENT:

The Logan River Motorcycle Trials Club, hereafter called the PROMOTING CLUB will conduct the Boonah Big Loop Trial, Round 4 QMTS Moto-Trial at Queensland Moto Park, Boonah on Sunday 8th May 2016, as per Permit Applications applied for.

#### 2 JURISDICTION:

The abovementioned meeting has been authorised by MQ who has issued the Motorcycling Australia Permit Number open to holders of current Motorcycling Australia National, Mini and One Meeting Licences.

The event will be held in accordance with the current General Competition Rules (GCR's) contained in the Manual of Motorcycle sport, the Australian Trials rules (20.6), these Supplementary Regulations, and any Final Instructions verbal or otherwise, with prior approval from Motorcycling Queensland

By entering this meeting all parties agree to comply with these rules, regulations, by-laws and instructions

#### 3 **ENTRIES:**

- Entries are preferred through the online www. Nominate.Com. Entry forms and cheque payments can also be posted to the 3.1 Competition Secretary, Peter Gately, closing date Wednesday, 4th May.
- 3.2 In the case of postponement or abandonment of the meeting, all or any part of the entry fee may be retained by the Club, if such retention is approved by MQ.
- 3.3 Only entries received on the official Entry Form that are accompanied by the correct fee will be accepted. A 'self-scrutineering form' is also to be completed in full and is part of the Entry Form for this event.

#### 4 **INSURANCE:**

- 4.1 National Personal Accident Scheme provides basic cover for death and permanent disability.
- 4.2 Ambulance Insurance is compulsory for licensees.
- 4.3 It is strongly recommended that competitors give consideration to taking out weekly benefits insurance.

#### 5 MEDICAL SERVICES:

A First Aid Attendant will be on site.

#### 6 **ENTRY FEE:**

- 6.1 Solo - \$40.00; Junior - \$20.00; Minibike - \$15.00; Sidecar - \$40.00; Family entry - \$50.00 (includes 1 adult rider and any number of under 18yo riders in family)
- Payment by Cheque or Money Order. The preferable method is to use the online www.Nominate.com.au at a minimal cost of \$1.43 6.2
- 6.3 Cheques and Money Orders are to be made payable to the Logan River Motorcycle Trials Club. One Meeting Competition Licence cost is \$55.00.

**REFUNDS**: Will be at the discretion of the promoter.

PLEASE NOTE: All competitors may enter one class only

#### 9 AWARDS AND PRIZEMONEY:

The Family of Craig Gillies is donating re-badged trophies once belonging to Craig, a legendary Logan River Club member

#### 10 ENTRIES TO CONSTITUTE A CLASS:

3 x entries to constitute a class

#### 11 RACE FORMAT:

3 x Laps of 10 sections with 6 x lines denoted by arrow colours- red, yellow, blue +, blue, white and the 'open' line (no arrows)

#### 12 MACHINES AND RIDERS:

- 12.1 All machines entered must comply with the current GCR's for Moto Trials Competition.
- 12.2 Multiple entry of the one Machine in the same Class of Competition is not permitted.
- 12.3 Change of machine may be allowed at discretion of the Steward.
- 12.4 Helmets are mandatory. All persons including officials using any bike (including pushbikes), trike or quad at an event must be wearing a properly secured helmet.

#### 13 RIDING NUMBERS:

The Number Plate on the Machine MUST comply with the GCR's. Background colour of numberplate is to be the same as the colour of the line to be followed. Mini-bike is to have Black background, to denote riding the 'open' line. C+ requires a white plus symbol to be clearly visible on the Blue background.

## 14 GRID POSITIONS:

#### 15 RIDERS BRIEFING:

A Riders Briefing will be held prior to the commencement of competition and ALL Competitors MUST attend the Riders Briefing. Riders Briefing is a Non Smoking Area.

## 16 DRUG AND/OR ALCOHOL TESTING:

- 16.1 All competitors and officials are advised that as part of the MA drug education program, drug testing may take place at any competition in accordance with Australian Sports Commission policy as implemented by the Australian Sports Drug Agency.
- 16.2 If any doubts exist over banned substances it is recommended competitors telephone the Drugs in Sport Hotline 1800 020506. When drug testing takes place, the payment of prize money may be delayed at MQ discretion until the results of the tests are known.

#### 17 CODE OF CONDUCT:

All Competitors, Officials and Parents are reminded of the Motorcycling Australia By-Law - CODE OF CONDUCT (as stipulated in the GCRs) which is a guide to appropriate behaviour at all Motorcycle Race Meetings. This CODE OF CONDUCT applies to this Meeting and will be enforced.

However, a rider may move to the next higher class when he/she becomes eligible to do so at any time during the year, but once a rider moves to the higher age class in any competition, he/she may not move back to the lower age class. Points earned in a lower class will not transfer to the higher class. This rule will apply to all riders up to and including 16 year olds

HEREBY AGREE with Motorcycling Australia Limited ("MA") that I am by this agreement entitled to participate in the motorcycle activity/meeting listed in Schedule 2 (hereinafter called "the Meeting" or the "Event") at the venue listed at Schedule 3 (hereinafter called "the Venue") on the terms and conditions set out in this document.

#### 2. DEFINITIONS In this declaration:

- "Claim" means and includes any action, suit, proceeding, claim, demand, damage, cost or expense however arising including but not limited to negligence but does not include a claim against a Motorcycling Organisation under any right expressly conferred by its constitution or regulation:
- "Indemnitees" means and includes the persons, organisations and bodies corporate whose names appear in Schedule 1.
- "MA" means Motorcycling Australia Limited;
  "State Controlling Body" (SCB) means a state or territory motorcycling association affiliated as a member of MA;
- "Motorcycling Activities" means performing or participating in any capacity in any authorised or recognised Motorcycling Organisation event, meeting or
- "Motorcycling Organisation" means and includes MA, and the MA members (including the SCBs and affiliated clubs) and where the context so permits, their respective directors, officers, members, servants or agents.

#### 3. ACKNOWLEDGMENT OF RISKS, DANGERS & OBLIGATIONS

#### I ACKNOWLEDGE that:

- motorcycle sport is dangerous and that by engaging in the sport (whether as a competitor, recreational rider, coach, official or media) at the Meeting I take and am exposed to certain risks and dangers and am under certain obligations as follows:
- that I may be injured, physically or mentally, and may be killed;
- that my machinery or equipment may be damaged, lost or destroyed;
- that competitors may ride dangerously or with a lack of skill:
- that track or event conditions may be hazardous and may vary without warning or predictability;
- that organisers, officials, landowners/track operators and any agents or 8. MEDICAL representatives of those in charge of meetings are frequently obliged to make decisions under pressure of time/or events
- that any policy of insurance of or in respect of my life or physical or mental health may be voided;
- that there may be no or inadequate facilities for treatment or transport of me if I am injured:
- that I have an obligation to myself and to others to act safely and within the rules and regulations of MA;
- the Indemnitees do not make any warranty that the services at the Meeting will be provided with due care and skill or that any materials provided in connection with the services will be fit for the purpose for which they are supplied:
- to the extent that any warranty is implied it is excluded to the full extent permitted by law;

I authorise such actions being taken by the Indemnitees and agree to meet all costs associated with such action. I understand it is compulsory for me to have ambulance insurance in some form and I accept responsibility for the cost of ambulance transportation, ambulance cover and further agree to maintain ambulance cover during the term of my license / membership.
