#### 1. ANNOUNCEMENT:

Lower Mountains Motorcycle Club, hereafter called the PROMOTER, will conduct a One Day National Trial for solo competitors at, 1 Cheesmans Rd Cattai NSW 2756 on **SUNDAY 26th June 2016** 

#### 2. JURISDICTION:

- 2.1. The above-mentioned meeting has been authorised by Motorcycling NSW Limited (MNSW) who has issued the Motorcycling Australia Permit Number 7/16/62193 and is open to holders of current Motorcycling Australia National, and Restricted National competition licences.
- 2.2. The meeting will be held in accordance with the current General Competition Rules (GCR's), these Supplementary Regulations, the By-Laws of Motorcycling NSW and any final instructions.

BY ENTERING THIS MEETING ALL PARTIES AGREE TO COMPLY WITH THESE RULES, REGULATIONS, BY-LAWS AND INSTRUCTIONS.

#### 3. ENTRIES:

- 3.1 Entries open forthwith and must be received by Wednesday 22<sup>nd</sup> June 2016. If your entry may be late please call Kevin on 0401 431629 or email <a href="kevin zarczynski@hotmail.com">kevin zarczynski@hotmail.com</a> to confirm you are entering, and ensure your name is placed on the score sheets before the day.
- 3.2 In the case of postponement or abandonment of the meeting, all or any part of the entry fee may be retained by the Promoter, if such retention is approved by Motorcycling NSW.
- 3.3 Only entries received on the official entry form that is accompanied by the correct fee will be accepted.
- 3.4 Any rider who pays their entry fee on the day **will** be required to pay \$150 per rider unless prior arrangements have been made as per 3.1.
- 3.5 The return of entry fees for any rider withdrawing from the meeting is at the discretion of the promoter.

#### 4. INSURANCE:

- 4.1 National Capital Benefits Scheme provides basic cover for death and permanent disability.
- 4.2 Personal Accident and Ambulance Insurance is the responsibility of the individual.
- 4.3 It is strongly recommended that competitors give due consideration to taking out such insurance cover.

#### 8. GRADES OF COMPETITION:

8.1 The event will have sections set for the following rider grades, and appropriate grade lines:

**Expert** (Green Rider Name Plate, green section splits)

A (Red Rider Name Plate, red section splits)

**B** (Yellow Rider Name Plate, yellow section splits)

**C** (Blue Rider Name Plate, blue section splits)

Clubman (White Rider name plate, white section splits

Junior non competitive

(White Rider Name Plate, no section splits)

- 8.2 For all Championship classes, the number of entries received at the closing date will determine if the number is sufficient to constitute a championship. The closing date for entries will not be extended and if there are insufficient numbers, that class will not be run as a championship.
- 8.3 Riders will automatically be included in any class for which they are eligible without having to enter a special class on the day.

**Open Solo:** Those competitors, riding on a Senior Licence and who are graded in Expert and A grade,

and choose to compete in those grades will be awarded points in the NSW Open Championship as follows: - best placed Experts will be awarded points in the NSW Open

Championship followed by best placed A Graders etc. – Nameplate colour, as grade entered.

**Open Junior:** Those competitors, riding on a Junior Licence and who are graded in A, B, C or Clubman

grade and choose to compete in those grades will be awarded points in the NSW Junior Championship as follows: - best placed Junior in the highest grade a Junior is competing in will be awarded first place points in the Junior Championship etc. – Nameplate colour, as

grade entered

**Open Women** 

Those Women riders who are graded in A, B C or Clubman grade and choose to compete in those grades will be awarded points, in the NSW Women's Championship, as follows: - best placed Woman in the highest grade a woman is competing in will be awarded first place points in the NSW Women's Championship etc. – Nameplate colour, as grade entered

Junior 7-12

Those competitors riding on a Junior Licence and who are graded in A, B, C or Clubman grade and choose to compete in those grades will be awarded points in the NSW Junior Championship as follows: - best placed Junior in the highest grade a Junior is competing in will be awarded first place points in the Junior Championship etc. – Nameplate colour, as

grade entered

Youth Contested over the B Grade lines for riders who are under 21 years on the day.

Veteran



One class, Over 40: Contested over C Grade (Blue Name Plate) lines for riders who are over

40 on the day.

Masters:

Contested over the B Grade lines for riders who are 35 years or older on the day.

#### 9. AWARDS AND PRIZE MONEY:

9.1 All grades of competition will be awarded - 1st, 2nd, 3rd place awards.

In addition: All riders eligible for classes listed under 8.2 will be allocated points for their respective NSW Championship class. Special awards will be given for Best Veteran over 50 years, and Best Veteran over 60 years.

#### **10. ENTRIES TO CONSTITUTE A CLASS:**

- 10.1 For all Championship classes, the number of entries received at the closing date will determine if the number is sufficient to constitute a championship. The closing date for entries will not be extended and if there are insufficient numbers, that class will not be run as a championship.
- 10.2 To constitute a class for Motorcycling NSW championship points to be awarded, the number of contestants entered and competing in each class shall be ten (10) for open solo, Masters, Youth, Veterans, and eight (8) for open junior, junior 7-12, and women.
- 10.3 Should there be insufficient entries in any class of competition, the decision to run or cancel the class, or to combine events and re-distribute any awards, will be at the discretion of the Promoter, subject to Motorcycling NSW approval.

  All section lines will be offered regardless of entry numbers, i.e. Expert, A, B, C, Clubman, Junior Non Competitive.

#### 11. COMPETITION FORMAT:

- 11.1 The number of sections and laps will be advised on each day.
- 11.2 Clubman will ride anywhere within section boundaries and/or may be restricted further.
- 11.3 Expert, A, B, C, and Veteran riders will be further restricted.
- 11.4 Scoring will be as per GCR 23.12.3.2 –Trials.
- 11.5 There will be a 90 second time limit applied for all competitors per section.

#### **12. MACHINES AND RIDERS:**

- 12.1 All machines entered must comply with the current GCR's for TRIAL Competition.
- 12.2 Multiple entry of the one machine in the same class of competition is not permitted.
- 12.3 A competitor may finish the trial on a machine other than their own, provided they have first obtained the approval of the MA Steward.

#### **13. RIDING NUMBERS:**

13.1 All nameplates on machines MUST comply with the GCR rules pertaining to Trials machines. Headlights are not acceptable.

### 14. GRID POSITIONS:

#### **15. RIDERS BRIEFING:**

- 15.1 A riders briefing shall be held prior to the commencement of the Trial on the day.
- 15.2 ALL competitors and minders MUST attend the riders briefing.
- 15.3 Riders briefing sign on sheets may be used, and must be signed after the riders briefing by the competitor and minder as proof of attendance.

#### 16. DRUGS AND OR ALCOHOL TESTING:

16.1 By order of Motorcycling NSW, random drug &/or alcohol testing of participants (i.e. officials, competitors, mechanics, pit crew and any other person associated with the control, direction and operation of the competition) may take place prior to, or at any time during this meeting.



#### 17. CODE OF CONDUCT:

17.1 All competitors, officials and parents are reminded of the Motorcycling Australia - CODE OF CONDUCT which is a guide to appropriate behaviour at all motorcycle competition meetings. This CODE OF CONDUCT applies to this meeting and shall be enforced.

#### **18. TIMETABLE:**

- 18.1 Competitors to present their motorcycle to the Scrutineer by 9.40am on Sunday when machines will be impounded until the start at 10am.
- 18.2 Competitors must present their competition license (and log book for juniors) to the Race Secretary to confirm their entry before the rider's briefing.
- 18.3 While entries received on the day will incur a penalty as noted in 3.4 of these Supplementary Regulations, all riders and minder entries must be received and processed before the rider's briefing. Riders and minders entries will NOT be accepted after this time.
- 18.4 For the purposes of drug and alcohol testing, the commencement of the meeting will be deemed as 8am on each day. The completion of the meeting for the Official, Observer, Rider, Minder and support crew is at the completion of the meeting.

#### 19. CIRCUIT DESCRIPTION:

19.1 See Points 11, 15 and 18. Circuit, laps and sections will be advised at the riders briefing each day of competition

#### **20. STARTS**:

#### 22. NOISE and FUEL:

22.1 All machines must comply with the requirements of the GCR's.

#### 23. PAYG WITHOUT HOLDING:

The Pay As You Go Tax affects the payment of prize money. There will be no prize money. If you do not provide an ABN or declare the sport is a hobby, the Promoter may withhold 47% of prize money over \$50.00 which is otherwise payable to you. Please tick one of the boxes on the entry form and if appropriate provide your ABN to ensure the full amount of prize moneys paid to you.

#### 24. SPECIAL NOTES AND WARNINGS:

- 24.1 The event will not be breaking for lunch, so please ensure that you take this into account so as not to miss your time.
- 24.2 No bikes to be ridden in the area during the event other than by competitors and officials.
- 24.3 With the exception of Guide Dogs, no animals are permitted.
- 24.4 Any change of entry details on the morning of the Trial will be subject to a \$20 Fee.
- 24.5 Riders will attempt the sections in sequential order, with start section for each grade to be advised on the day.
- 24.6 No competitors are allowed to enter the sections before the start of the event.
- 24.7 The venue will not be open for practice of riding preceding the event.
- 24.8 There is no on site camping. The nearest camping site available is Pacific Park Ski Gardens. For local accommodation please google "accommodation South Maroota NSW"
- 24.9 There is no catering, electric power or fuel available on site. Nearest shops and service station are in Pitt Town.
