The Trials Club of Victoria Inc will be conducting a club trial at Newlans Lane, Heathcote on 10th and 11th of June 2018.
The Argyle 2 Day and Arron Booth Memorial Trial.

JURISDICTION :

The Trial will be held under the jurisdiction of the 2018 GCRs of Motorcycling Australia (MA) with the following supplementary regulations and any instructions issued on the day.

GRADES :

A+ and A Grade

B Grade, Masters.

C Grade, C+, Veterans 40 +, Twin Shock

Junior

Clubman

Sub Juniors

The organisers reserve the right to cancel or combine any grades with insufficient entries. The site is suitable for sub-juniors.

AWARDS :

As per subcommittee ruling (dependent on number of entries).

ENTRY FEE :

Solo \$70, Junior \$40, Family (3 people in total) \$110.

Entries close on Friday, 8th **June 2018 online** or post to The Event Secretary, 46 Pallet St, Golden Square. 3555

Entries on the day of the event will cost an additional \$10.00

HELMETS :

To AS1698 or other FIM approved standard.

DIRECTIONS :

From Tooborac, head towards Heathcote on the Northern Hwy (approx 9kms), turn left into Newlans Lane and travel 2.5kms to the paddock. (From Heathcote approx 6.5kms from P.O.) Will be signposted from the Highway on the day.

MEDICAL SERVICES:

On site first aid services will be provided. These services will be available between 9.45am and 4.00pm on both days of the event.

ANTI-DOPING POLICY:

All competitors and officials are advised that drug testing may take place in accordance with MA's Anti-Doping Policy, as carried out by the Australian Sports Anti-Doping Authority. Refer to GCR's.

CONTRACT TO PARTICIPATE IN MOTOR CYLCE SPORTING EVENT AND/OR ACTIVITY

HEREBY AGREE with the persons, organisations and bodies corporate whose name appear in Schedule 1 (hereinafter collectively called " The Organiser " that I am by this agreement entitled to participate in the motorcycle activity/meeting listed in Schedule 2 (hereinafter called " The Meeting" at the venue listed at Schedule 3 (hereinafter called "The Venue" on the terms and conditions set out in this document.

ACKNOWLEDGEMENT OF RISKS, DANGERS AND OBLIGATIONS

I ACKNOWLEDGE that motorcycle sport is dangerous and that by engaging in the sport and participating in the meeting I take and am exposed to certain risks and dangers and am under certain obligations as follows:

- a) that I may be injured, physically or mentally, and may be killed;
- b) that my machinery or equipment may be damaged, lost or destroyed;
- c) that the other competitors may ride dangerously or with lack of skill;
- d) that track or event conditions may be hazardous and may vary without warning or predictability;
- e) that organisers, officials, landowners, track operators and any agent or representatives of those in charge of meetings are frequently obliged to make decisions under pressure of time and / or events;
- f) that any policy of insurance of or in respect of my life or physical or mental health may be voided;
- g) that there may be no or inadequate facilities for treatment or transport of me if I am injured;
- h) that I have an obligation to myself and to others to compete safely and within the rules of the competition.

INDEMNITY GIVEN TO ORGANISERS

IN CONSIDERATION of the acceptance of me as an entrant in the meeting I AGREE TO INDEMNIFY the organisers and each of them in the following manner:
