1. ANNOUNCEMENT:

The GYMPIE MOTORCYCLE CLUB hereafter called the PROMOTING CLUB will conduct A NON STOP INTERCLUB TRIALS EVENT for JUNIORS AND SENIORS at the GAP ROAD, CEDAR POCKET, GYMPIE on 27TH MAY, 2018 as per permit applications applied for.

2. JURISDICTION:

- 2.1. The abovementioned meeting has been authorised by MQ who has issued the Motorcycling Australia Permit Number TBA and is open to holders of current Motorcycling Australia NATIONAL, NATIONAL RESTRICTED, ONE MEETING LICENCES AND RECREATIONAL NON-COMPETITIVE Licences. (OML to Junior riders if they hold and present a current JCP Log Book), who are full financial members of the participating clubs, MTCQ, WDTC, LRMTC, and CQTC or GMCC.
- 2.2. The meeting will be held in accordance with the current Manual of Motorcycle Sport General Competition Rules (GCR's), these Supplementary Regulations, and any Final Instructions approved by [INSERT RCB]. BY ENTERING THIS MEETING ALL PARTIES AGREE TO COMPLY WITH THESE RULES, REGULATIONS, BY-LAWS AND INSTRUCTIONS.

3. ENTRIES:

- 3.1. Entries open forthwith and will be accepted on the day of the meeting before briefing. No cheques will be accepted. Payment on line prior to the day of the meeting would be appreciated and will be accepted up until Thursday 24th May. Printed receipt plus all completed forms must be presented to registration desk on the day.
- 3.2. In the case of postponement or abandonment of the meeting, all or any part of the entry fee may be retained by the Gympie Motor Cycle Club, if such retention is approved by MQ.
- 3.3. Only entries received on the official Entry Form that is accompanied by the correct fee will be accepted.
- 3.4. <u>NOTE:</u> JUNIORS MUST BE UNDER THE AGE OF 16 AT THE 1ST JANUARY 2018. THE RETURN OF ENTRY FEES FOR ANY RIDER WITHDRAWING FROM THE MEETING IS AT THE DISCRETION OF THE GYMPIE MOTOR CYCLE CLUB.

4. INSURANCE:

- 4.1. National Personal Accident Scheme provides basic cover for death and permanent disability.
- 4.2. Ambulance Insurance is compulsory for licensees.
- **4.3.** IT IS STRONGLY RECOMMENDED THAT COMPETITORS GIVE CONSIDERATION TO TAKING OUT WEEKLY BENEFITS INSURANCE.

5. MEDICAL SERVICES:

A senior first aider from the Gympie Volunteer First Aid Service will be in attendance for the meeting.

6 ENTRY FEE:

- 6.1. SENIOR RIDER \$60.00/ JUNIOR RIDER \$20.00/ MINDER \$20.00/ OML \$50.00/ FAMILY FEE \$85.00 (Family is one Senior Rider and any number of Junior Riders in the Senior Rider's immediate family).
- 6.2. Payment by CASH OR ON LINE only. If paying on line, payment required by Thursday 24th May 2018. Bank Account Name Gympie Motor Cycle Club / BSB 124001/ACC 10181654
- 6.3. REFUNDS will be at the discretion of the promoting club.

7 CLASSES OF COMPETITION:

White Line and Blue Line

Demonstration Class (For those riding on a rec licence, not competing and for no award).

8 AWARDS AND PRIZEMONEY:

Winner of each class (Blue and White) will receive \$200.00. 2nd AND 3rd placegetters in each class will receive a medallion.

9 ENTRIES TO CONSTITUTE A CLASS:

10.1. To constitute a Class, the number of contestants entered and competing in each Class shall be 5. Should there be insufficient entries in any Class of Competition, the decision to run or cancel the Class, or to combine events and re-distribute any awards and / or prizemoney, will be at the discretion of the Gympie Motor Cycle Club, subject to MQ approval.

11. RACE FORMAT:

Competition Day will consist of sections of man made obstacles to a timed and point system, ridden to the NON STOP RULE.

12 MACHINES AND RIDERS:

- 12.1. All machines entered must comply with the current GCR's for Moto Trials Competition.
- 12.2. Multiple entry of the one Machine in the same Class of Competition is not permitted.
- 12.3. COMPETITORS ARE TO PRESENT THEMSELVES FOR COMPETITION INCLUDING HELMET WHICH IS IN GOOD CONDITION AND COMPLIES WITH APPENDIX A, PROTECTIVE CLOTHING, EQUIPMENT OF THE GCRs TOGETHER WITH BIKE, COMPETITION LICENCE AND SCRUTINEERING FORM AT THE TIME LISTED BELOW.
- 12.4 Minders should be suitably dressed including closed footwear.
- 12.5 No change of machinery will be allowed.
- 12.6 Motorcycle tyres will be Trials Universal Pattern.
- 12.7 Helmets are mandatory. All persons including officials, using any bike (including push bikes, trike or quad) at the event must be wearing a properly secured helmet.
- 13 NAME PLATES: Identification plates on all machines must comply with the GCRs and colours to match the riders' gradings.

14 RIDERS BRIEFING:

A Riders Briefing will be held prior to the commencement of competition and ALL Competitors MUST attend the Riders Briefing. Details will be included in Final Instructions. RIDERS BRIEFING IS A NON SMOKING AREA.

15 DRUG AND OR ALCOHOL TESTING:

- **15.1** All competitors and officials are advised that as part of the MA drug education program, drug testing may take place at any competition in accordance with Australian Sports Commission policy as implemented by the Australian Sports Drug Agency.
- 15.2 If any doubts exist over banned substances it is recommended competitors telephone the Drugs in Sport Hotline 1800 020506. When drug testing takes place, the payment of prizemoney may be delayed at the MQ discretion until the results of the tests are known.

17 CODE OF CONDUCT:

All Competitors, Officials and Parents are reminded of the Motorcycling Australia By-Law - CODE OF CONDUCT (as stipulated in the GCR's) which is a guide to appropriate behaviour at all Motorcycle Race Meetings. This CODE OF CONDUCT applies to this Meeting and will be enforced.

19 CIRCUIT DESCRIPTION:

Trial will consist of a series of man made obstacles with a timed and point scoring system, under the non stop rule.

20 RACING:

This is a trial and not a race. However, the event will involve a race against the clock.

21. SPECIAL NOTES AND WARNINGS:

Competitors will incur a one point penalty per every minute late beyond the sign-on and exclusion after sixty minutes late. No dogs allowed.

24.2 FACILITIES: Toilets on site. Bring plenty of drinking water.

25 DIRECTIONS: Follow along Tin Can Bay (Brisbane Rd) off the Bruce, coming from the south, and proceed for about 8.4 kms to the Cedar Pocket Rd, turn off on right. Follow C P Road for about 20 kms. Pass Cedar Pocket Dam on right and continue on following into Gap Rd, then about about 4 kms along the site will be on the left. Once inside the property, follow the signs to the site.

From the North, take KFC left into Channon St and follow the signs to Tin Can Bay. Cedar Pocket Rd will not be far from exit onto TCB Rd.

CONTRACT TO PARTICIPATE IN THE GMCC INTERCLUB MOTO TRIAL WARNING! THIS IS AN IMPORTANT DOCUMENT WHICH AFFECTS YOUR LEGAL RIGHTS AND OBLIGATIONS. PLEASE READ IT CAREFULLY AND DO NOT SIGN IT UNLESS

YOU ARE SATISFIED YOU UNDERSTAND IT. 1. I THE UNDERSIGNED (see below): [Insert Name]

HEREBY AGREE with Motorcycling Australia Limited ("MA") that I am by this agreement entitled to participate in the motorcycle activity/meeting listed in Schedule 2 (hereinafter called "the Meeting" or the "Event") at the venue listed at Schedule 3 (hereinafter called "the Venue") on the terms and conditions set out in this document.

2. DEFINITIONS In this declaration:

- "Claim" means and includes any action, suit, proceeding, claim, demand, damage, cost or expense however arising including but not limited to negligence but does not include a claim against a Motorcycling Organisation under any right expressly conferred by its constitution or regulation;
- b) "Indemnitees" means and includes the persons, organisations and bodies corporate whose names appear in Schedule 1.
- "MA" means Motorcycling Australia Limited;
- "State Controlling Body" (SCB) means a state or territory motorcycling association affiliated as a member of MA; d)
- "Motorcycling Activities" means performing or participating in any e) capacity in any authorised or recognised Motorcycling Organisation event, meeting or activity;
- "Motorcycling Organisation" means and includes MA, and the MA f) members (including the SCBs and affiliated clubs) and where the context so permits, their respective directors, officers, members, servants or agents.

3. ACKNOWLEDGMENT OF RISKS, DANGERS & OBLIGATIONS

I ACKNOWLEDGE that:

- motorcycle sport is dangerous and that by engaging in the sport a) (whether as a competitor, recreational rider, coach, official or media) at the Meeting I take and am exposed to certain risks and dangers and am under certain obligations as follows:
- that I may be injured, physically or mentally, and may be killed; that my machinery or equipment may be damaged, lost or destroyed; i)
- ii)
- that competitors may ride dangerously or with a lack of skill; iii) iv) that track or event conditions may be hazardous and may vary
- without warning or predictability; that organisers, officials, landowners/track operators and any agents v) or representatives of those in charge of meetings are frequently obliged to make decisions under pressure of time/or events;
- that any policy of insurance of or in respect of my life or physical or vi) mental health may be voided;
- that there may be no or inadequate facilities for treatment or transport of me if I am injured; vii)
- vii) that I have an obligation to myself and to others to act safely and within the rules and regulations of MA;
- the Indemnitees do not make any warranty that the services at the b) Meeting will be provided with due care and skill or that any materials provided in connection with the services will be fit for the purpose for which they are supplied;
- c) to the extent that any warranty is implied it is excluded to the full extent permitted by law;
- have voluntarily read and understood this warning and accept and d) assume the inherent risks in participating in the Event

4. WARNING UNDER THE FAIR TRADING ACT 1999 (VIC)

- Under the provisions of the Fair Trading Act 1999 (Vic) several conditions are implied into contracts for the supply of certain goods and services. These conditions mean that the supplier named on this form is required to ensure that the recreational services it supplies to you are: - rendered with due care and skill;
- as fit for the purpose for which they are commonly bought as it is reasonable to expect in the circumstances; and
- reasonably fit for any particular purpose or might reasonably be expected to achieve any result you have made known to the supplier

Under section 32N of the Fair Trading Act 1999, the supplier is entitled to ask you to agree that these conditions do not apply to you. If you sign this form, you will be agreeing that your rights to sue the supplier under the Fair Trading Act 1999 if you are killed or injured because the services were not rendered with due care and skill or they were not reasonably fit for their purpose, are excluded, restricted or modified in the way set out in this form. <u>NOTE:</u> The change to your rights, as set out in this form, does not apply if your death or injury is due to gross negligence on the supplier's part. "Gross negligence" is defined in the Fair Trading (Recreational Services) Regulations 2004.

For the purposes of the clause 3, "the Supplier" shall mean and include the Indemnitees

5. INDEMNITY AND RELEASE GIVEN TO ORGANISERS

- IN CONSIDERATION of the acceptance of me as a participant in the Meeting a) I AGREE TO INDEMNIFY AND KEEP INDEMNIFIED to the full
- extent permitted by law the Indemnitees and each of them in the following manner
- that I participate in the meeting at my sole risk and responsibility; ii) that I accept the Venue as it stands with all or any defects hidden or exposed
- iii) that I indemnify and hold harmless the Indemnitees, their respective servants, agents, officials and competitors against any actions, costs, losses or claims which may be made by me or on my behalf for or in respect of or arising out of my death or any injury loss or damage caused to me or my equipment whether caused by negligence, breach of contract or in any other manner whatsoever.

- A term of this release and indemnity will not apply where the term contravenes the law of the relevant jurisdiction under which any legal d) action is legitimately taken however such terms are severable and do not invalidate the remaining terms.

6. MEDICAL

I declare that I am and must continue to be medically and physically fit and able to participate in the Meeting. I will immediately notify MA in writing via my SCB of any change to my fitness and ability to participate. I understand and accept the Indemnitees will continue to rely upon this declaration as evidence of my fitness and ability to participate.

I acknowledge and agree that if required, the Indemnitees (or any of them) may arrange medical or hospital treatment (including ambulance transportation) for me. I authorise such actions being taken by the Indemnitees and agree to meet all costs associated with such action. I understand it is compulsory for me to have ambulance insurance in some form and I accept responsibility for the cost of ambulance transportation, ambulance cover and further agree to maintain ambulance cover during the term of my license / membership.

7. PRIVACY

I hereby consent to the collection of my personal information by the Promoter/Event Organiser, MA and the SCB in connection with my involvement at the Event and the use and disclosure of my personal information by Event Organiser, and MA to other agencies and officials associated with the Event for the purposes of conducting and managing the Event. I understand that if I do not provide the personal information requested above that I may not be permitted to participate in the Event.

facility providers of MA / SCB permitted events, and generally to reduce the risks to persons engaged in motorcycle sport; and It is reasonable for MA and my SCB to collect, store, use and disclose my

- iii) Information in accordance with clause 11(a)(i) above and in the manner set out in clause 11(b)
- IN CONSIDERATION of my acceptance as an entrant in the Meeting b) I consent and agree that MA and my SCB:
