

1. ANNOUNCEMENT:

Pacific Park Trials Club, hereafter called the PROMOTER, will conduct a Two Day National Moto-Trial for solo competitors at Pacific Park, Pacific Park Drive, South Maroota, NSW 2756, on **SATURDAY 24**th of August and **SUNDAY 25**th of August 2019

2. JURISDICTION:

- 2.1. The above-mentioned meeting has been authorised by Motorcycling NSW Limited (MNSW) who has issued the Motorcycling Australia Permit Number ******** and is open to holders of current Motorcycling Australia National, and Restricted National, Competition Licences.
- 2.2. The meeting will be held in accordance with the current General Competition Rules (GCR's), these Supplementary Regulations, the By- Laws of MNSW and any Final Instructions.

BY ENTERING THIS MEETING ALL PARTIES AGREE TO COMPLY WITH THESE RULES, REGULATIONS, BY-LAWS AND INSTRUCTIONS.

3. ENTRIES:

- 3.1 Entries open forthwith and must be received by Saturday 17th of August
- 3.2 In the case of postponement or abandonment of the meeting, all or any part of the entry fee may be retained by the Promoter, if such retention is approved by MNSW.
- 3.3 Only entries received on the official Entry Form that are accompanied by the correct fee will be accepted.
- 3.4 Any entry monies paid on the day will be \$150 per rider.
- 3.5 The return of entry fees for any rider withdrawing from the meeting is at the discretion of the promoter.

4. INSURANCE:

- 4.1 National Capital Benefits Scheme provides basic cover for death and permanent disability.
- 4.2 Personal Accident and Ambulance Insurance is the responsibility of the individual.
- 4.3 It is strongly recommended that competitors give due consideration to taking out such insurance cover.

5. MEDICAL SERVICES:

5.1 Certified First Aid Officer will be in attendance.

6. ENTRY FEE: ENTRY FEE:

6.1 **Both days**: Senior \$110, Junior \$60, Family \$160 (1 senior and up to 3 Juniors or 1 senior full price and additional seniors \$70 each ALL living at the same address), Minder \$45

One day only: Senior \$70, Junior \$40, Family \$110. Minder \$35.

7. CLASSES OF COMPETITION:

7.1 The event is open to the following Grades:

Trial 1 (Green Name Plate)
Trial 2 (Red Name Plate)
Trial 3 (Yellow Name Plate)
Trial 4 (Blue Name Plate)

Trial 5 (White Name Plate) – [Jack Smith Clubman Trophy]

7.2 NSW Championship Classes will include:

Open Solo: Those competitors, riding on a Senior Licence and who are graded in Trial 1 and Trial 2 and

choose to compete in those grades will be awarded points in the NSW Open Championship as follows: - best placed Trial 1 will be awarded points in the NSW Open Championship followed

by best placed Trial 2 etc. - Nameplate colour, as grade entered

Open Junior: Those competitors, riding on a Junior Licence and who are graded in Trial 2,3 or 4 and choose

to compete in those grades will be awarded points in the NSW Junior Championship as follows: - best placed Junior in the highest grade a Junior is competing will be awarded first

place points in the Junior Championship etc. - Nameplate colour, as grade entered

Open Women Those Women riders who are graded in Trial 2,3,4 or Trial 5 and choose to compete in those

grades will be awarded points, in the NSW Women's Championship, as follows: - best placed Woman in the highest grade a woman is competing will be awarded first place points in the

NSW Women's Championship etc. – Nameplate colour, as grade entered

Junior Those women competitors, riding on a Junior Licence and who are riding machines that meet

Women: restrictions on engine capacity GCR 18.5 run over the Trial 5 lines White Name plates

Veteran (2 Run over Trial 4 (Blue Name Plate) lines for riders who are: 40-54, 55+ on the day.

classes):

Run over the Trial 3 (yellow plate) lines for riders who are 35 years or older on the day.

Masters:

Those competitors aged 13 to under 19 years at the first day of competition (GCR's 18.1) -

Youth: run over the Trial 3 lines.

Those competitors, riding on a Junior Licence and who are riding machines that meet

Junior 7-12: restrictions on engine capacity as specified in MOMS 23.2.2.1 run over the Trial 5 lines White

Name plates.

8. AWARDS AND PRIZE MONEY:

8.1 All NSW Championship Classes will be awarded - 1st, 2nd, 3rd place trophies for the combined scores of both days. There will also be a special award to the winner in the "Trial 5" class of the Jack Smith Memorial Trophy

9. ENTRIES TO CONSTITUTE A CLASS:

- 9.1 To constitute a Class, the number of contestants entered and competing in each Class shall be Five (5).
- 9.2 Should there be insufficient entries in any Class of Competition, the decision to run or cancel the Class, or to combine events and re-distribute any awards, will be at the discretion of the Promoter, subject to MNSW approval.

10. COMPETITION FORMAT:

- 10.1 The number of sections and laps will be advised on each day.
- 10.2 Trial 5 and Junior will ride anywhere within section boundaries and/or may be restricted further.
- 10.3 Trial 1,2,3,4, Masters, and Veteran riders will be further restricted.
- 10.4 Scoring will be as per GCR 18.11.3.2 -Trials.
- 10.5 There will be a 90 second time limit applied for all competitors per section.

11. MACHINES AND RIDERS:

- 11.1 All machines entered must comply with the current GCR's for TRIAL Competition.
- 11.2 Multiple entry of the one Machine in the same Class of Competition is not permitted.
- 11.3 A competitor may finish the trial on a machine other than their own, provided they have first obtained the approval of the MA Steward.

12. RIDING NUMBERS:

12.1 All Nameplates on Machines MUST comply with the GCR 18.10.1.1 and 18.10.2.1 Headlights are not acceptable.

13. RIDERS BRIEFING:

- 13.1 A Riders Briefing shall be held prior to the commencement of the Trial on each day.
- 13.2 ALL Competitors and Minders MUST attend the Riders Briefing.
- 13.3 Riders Briefing Sign on sheets must be signed after the Riders Briefing by the Competitor and Minder as proof of attendance.

14. DRUG AND OR ALCOHOL TESTING:

14.1 By order of MNSW, random drug &/or alcohol testing of participants (i.e. officials, competitors, mechanics, pit crew and any other person associated with the control, direction and operation of the competition) may take place prior to, or at any time during this meeting.

15. CODE OF CONDUCT:

15.1 All Competitors, Officials and Parents are reminded of the Motorcycling Australia By-Law - CODE OF CONDUCT (as stipulated on page 258 of the 2010 GCR's) which is a guide to appropriate behaviour at all Motorcycle Competition Meetings. This CODE OF CONDUCT applies to this Meeting and shall be enforced.

16. TIMETABLE:

- 16.1 Competitors to present their motorcycle to the Scrutineer by 10.40am on the Saturday when Machines will be impounded until the start at 11am.
- 16.2 Competitors to present their motorcycle to the Scrutineer by 08.40am on the Sunday when Machines will be impounded until the start at 9am.
- 16.3 Competitors must present their Competition License (and log book for juniors) to the Race Secretary to confirm their entry before the Rider's Briefing.
- 16.4 While entries received on the day will incur a penalty, all riders and minder entries must be received and processed before the rider's briefing. Riders and minders entries will NOT be accepted after this time.
- 16.5 For the purposes of drug and alcohol testing, the commencement of the meeting will be deemed as 8am on each day. The completion of the meeting for the Official, Observer, Rider, Minder and support crew being the completion of his/her participation in the meeting.

17. NOISE and FUEL:

17.1 All machines must comply with the requirements of the GCR's.

18. SPECIAL NOTES AND WARNINGS:

- 18.1 There will be no lunch breaks.
- 18.2 No bikes to be ridden in the area during the event other than by Competitors and Officials.
- 18.3 No animals permitted. (Guide dogs exempted).



18.4 Any change of Entry details on the morning of the Trial will be subject to a \$20 Fee.


18.5 Start time on Saturday will be 11am to allow for riders travelling to the event

HEREBY AGREE with Motorcycling Australia Limited ("MA") that I am by this agreement entitled to participate in the motorcycle activity/meeting listed in Schedule 2 (hereinafter called "the Meeting" or the "Event") at the venue listed at Schedule 3 (hereinafter called "the Venue") on the terms and conditions set out in this document.

DEFINITIONS

- In this declaration:
- "Claim" means and includes any action, suit, proceeding, claim, demand, damage, cost or expense however arising including but not limited to negligence but does not include a claim against a Motorcycling Organisation under any right expressly conferred by its constitution or regulation;
- "Indemnitees" means and includes the persons, organisations and bodies corporate whose names appear in Schedule 1.
- "MA" means Motorcycling Australia Limited;
 "State Controlling Body" (SCB) means a state or territory motorcycling association affiliated as a member of MA;
- "Motorcycling Activities" means performing or participating in any capacity in any authorised or recognised Motorcycling Organisation event, meeting or activity;
- "Motorcycling Organisation" means and includes MA, and the MA members (including the SCBs and affiliated clubs) and where the context so permits, their respective directors, officers, members, servants or agents.

ACKNOWLEDGMENT OF RISKS, DANGERS & OBLIGATIONS

- I ACKNOWLEDGE that:
- motorcycle sport is dangerous and that by engaging in the sport (whether as a competitor, recreational rider, coach, official or media) at the Meeting I take and am exposed to certain risks and dangers and am under certain obligations as follows:
- that I may be injured, physically or mentally, and may be killed; that my machinery or equipment may be damaged, lost or
- that competitors may ride dangerously or with a lack of skill;
- that track or event conditions may be hazardous and may vary without warning or predictability; that organisers, officials, landowners/track operators and any
- or representatives of those in charge of meetings are frequently obliged to make decisions under pressure of time/or
- that any policy of insurance of or in respect of my life or physical or mental health may be voided; that there may be no or inadequate facilities for treatment or
- transport of me if I am injured; that I have an obligation to myself and to others to act safely and
- within the rules and regulations of MA;
- the Indemnitees do not make any warranty that the services at the Meeting will be provided with due care and skill or that any materials provided in connection with the services will be fit for the purpose for which they are supplied;
- to the extent that any warranty is implied it is excluded to the full extent permitted by law;
- have voluntarily read and understood this warning and accept and assume the inherent risks in participating in the Event.

WARNING UNDER THE FAIR TRADING ACT 1999 (VIC)

 - be expected to achieve any result you have made known to the

Under section 32N of the Fair Trading Act 1999, the supplier is entitled to ask you to agree that these conditions do not apply to you. If you to ask you to agree that these conditions do not apply to you. If you sign this form, you will be agreeing that your rights to sue the supplier under the Fair Trading Act 1999 if you are killed or injured because the services were not rendered with due care and skill or they were not reasonably fit for their purpose, are excluded, restricted or modified in the way set out in this form.

NOTE: The change to your rights, as set out in this form, does not apply if your death or injury is due to gross negligence on the supplier's part. "Gross negligence" is defined in the Fair Trading (Recreational Services) Regulations 2004.

- I acknowledge and agree that if required, the Indemnitees (or any of them) may arrange medical or hospital treatment (including ambulance transportation) for me. I authorise such actions being taken by the Indemnitees and agree to meet all costs associated with such action. I understand it is compulsory for me to have ambulance insurance in some form and I accept responsibility for the cost of ambulance transportation, ambulance cover and further agree to maintain ambulance cover during the term of my license / membership
