

1. ANNOUNCEMENT:

Trials Club of Canberra, hereafter called the PROMOTER, will conduct a TCC/TRA Interclub Trial for solo and sidecar competitors at, 'The Hills', Murringo, NSW, 2568 on **Sunday 12**th **July 2020**

2. JURISDICTION:

- 2.1. The above-mentioned TCC/TRA Interclub meeting has been authorised by Motorcycling NSW Limited (MNSW) who has issued the Motorcycling Australia Permit Number 20/C/1950 and is open to holders of current Motorcycling Australia National CompetitionLicences riding a Trials motorcycle.
- 2.2. One Event Licences will be accepted, but must be purchased prior to the event and details supplied with your Entry Form prior to Close of Entries.
- 2.3. The meeting will be held in accordance with the current General Competition Rules (GCR's), these Supplementary Regulations, the By-Laws of Motorcycling NSW, all appropriate Covid-19 restrictions, and any final instructions. BY ENTERING THIS MEETING ALL PARTIES AGREE TO COMPLY WITH THESE RULES, REGULATIONS, BY-LAWS AND INSTRUCTIONS.

3. <u>ENTRIES:</u>

- 3.1 Entries open forthwith and must be received by us by cob **Friday 10th July 2020**
- 3.2 In the case of postponement or abandonment of the meeting, all or any part of the entry fee may be retained by the promoter, if such retention is approved by Motorcycling NSW.
- 3.3 Only entries received on the Official Entry Form that are accompanied by the correct fee will be accepted.
- 3.4 Pre entries are essential.

- 8.1 The event will have sections set for the following rider classes, and appropriate grade lines:

 - **Trial 3** (Yellow nameplate, and splits) (similar to old B Grade)
 - **Trial 4** (Blue nameplate, and splits) (similar to old C and C+ Grade)
 - Trial 5 (White nameplate, and splits) (similar to old Clubman)
 - **Trial 6** (Orange nameplate) new Entry Level no splits
- 8.2 Your nameplate should be the colour of the class you are entering. Sidecars yellow plate, but will ride around white splits.
- 8.3 The intention of the Organiser is to put the onus on the rider as to which class they enter.

9. AWARDS AND PRIZEMONEY:

- 9.2 Points awarded for the NSW TROY Series by the MNSW Trials Committee.

10. ENTRIES TO CONSTITUTE A CLASS:

- 10.1 To constitute a class, the number of contestants entered and competing in each class shall be three (3).
- 10.2 Should there be insufficient entries in any class of competition, the decision to run or cancel the class, or to combine classes, will be at the discretion of the promoter.
- 10.3 Please note that Juniors, Twinshocks, Sidecars, Classics, Electric bikes, Air Cooled Monos, Veterans will all ride whatever class they enter. The MNSW Trials Committee may choose to split the results for some, or all, of those groups

11. <u>RIDING FORMAT:</u>

- 11.1 The Trial will be run under "TRIAL" rules. GCR Chapter 17 in 2020 MoMS
- 11.2 The number of sections and laps will be confirmed on the day.
- 11.3 Scoring will be as per GCR 17.11.3.2 –Trials.

12. MACHINES AND RIDERS:

- 12.1 All machines entered must comply with the current GCR's for TRIAL competition.
- 12.2 No sharing of machine or equipment.
- 12.3 Noise &/or Fuel Testing may be carried out at any time during this meeting.

13. <u>RIDING NUMBERS:</u>

13.1 All Nameplates on Machines MUST comply with the GCR rules pertaining to Trials machines. Headlights are not acceptable.

A Riders' briefing will be held prior to the commencement of the Trial on each day, and all participants MUST attend. Riders must maintain Social Distancing at the Riders briefing. The CoC will use a PA system.

By order of Motorcycling NSW, random drug &/or alcohol testing of participants (i.e. officials, competitors, mechanics, pit crew and any other person associated with the control, direction and operation of the competition) may take place prior to, or at any time during this meeting.
